INSTRUCTION MANUAL HOW TO WEAR IT: POSITION

In order to ensure maximum protection, the helmet should be worn, adjusted and fastened correctly. Be sure to choose the right size for you.

(S:48-52cm; 19-20in / M: 54-57cm; 21-22in)

When worn, the helmet should remain aligned with the line connecting your ear and eyebrow. Your helmet has a rear dial that allows to fit the helmet perfectly to the head.

Hold the front of the helmet and rotate the dial until you have a firm and comfortable fit

- A helmet cannot always protect against injury
- A helmet subjected to a severe impact should be discarded and destroyed
- Do not modify or remove any of the original component parts, other than as recommended by the manufacturer
- Helmets should not be adapted for the purpose of fitting accessories in a way not recommended by the manufacturer
- The helmet can only protect if it fits well. The buyer should try different sizes and choose the size which feels secure and comfortable on the head The helmet should be adjusted to fit the user, e.g. the straps positioned so that they do not cover the ears, the buckle positioned away from the jawbone and the straps and buckle adjusted to be both comfortable and firm
- · Recommends replacing a helmet every 2 to 3 years Do not throw, drop, or use helmet as support. As with
- any piece of specialized equipment this helmet must not be abused. Store helmet in clean, dry environment, not over 40° C Wipe clean with a damp cloth
